RELEASE OF LIABILITY

PLEASE READ CAREFULLY BEFORE SIGNING

I understand that Project Ascent, LLC (hereinafter “PA”) programs are often considered physically and/or emotionally demanding. These programs, which may include, among other things, activities on a ropes challenge course, traveling, caving and rock climbing, are potentially hazardous and there is a risk of injury. I have made a voluntary choice to participate in these activities despite the risks that they present. I understand that the level of participation in PA program activities is, at all times, my choice. I represent that my health is good, and that I am not under a physician’s care for any undisclosed condition that may bear upon my fitness to participate in PA program activities.

In consideration of being permitted to participate in any PA activities, I agree to assume the risks incidental to such participation and/or use of PA equipment or facilities (which risks may include, among other things, muscle injuries, broken bones and/or emotional distress) and, to the fullest extent permitted by law, I hereby release and forever discharge the Released Parties (as defined below) of and from any and all liabilities, claims, actions, damages, costs and expenses of any nature arising out of or in any way related to my participation in an activity conducted by PA. I further agree to indemnify, defend and hold each of the Released Parties harmless from and against any and all such liabilities, claims, actions, damages, costs, and expenses, including, but not limited, to, all attorney's fees and disbursements. I fully understand that this Release includes any claims based on the negligence, action or inaction of the Released Parties and covers bodily injury (including, but not limited to, death) and property damage, whether suffered by me, or my child or ward, before, during or after such participation in any activity conducted or sponsored by PA.

In consideration of being permitted to participate in PA activities, I irrevocably grant to PA the right to use my image and name in all forms and media including composite or modified representations for all purposes, including advertising, trade or any commercial purpose in perpetuity. I waive the right to inspect or approve versions of my image used for publication or the written copy that may be used in connection with the images. I release PA from any claims that may arise regarding the use of my image including any claims of defamation, invasion of privacy, or infringement of moral rights, rights of publicity or copyright.

I authorize medical treatment for me at my cost if the need arises.

I understand that I may be asked to leave any venue should I exhibit undesirable conduct.

The laws of the State of Maryland shall govern this Agreement. I certify I am at least 18 years of age.

As used herein (a) “Released Parties” refers to Project Ascent, LLC, a Maryland limited liability company, together with any parent, subsidiary, affiliated and related entities, and the members (including, but not limited to, Brennan A Gross AKA Avi Gross), officers, directors, employees, agents, representatives, successors, and assigns of each of the foregoing entities, and (b) “I” “me” and “my” refers to the person signing this Release as well as each of their heirs, executors and administrators. If the participant in the PA activity is a minor, then this Release must be signed by their parent or legal guardian, and the terms contained herein shall be binding upon each of them, as well as their heirs, executors and administrators.

I, the undersigned, have carefully read and understand this Agreement and all its terms. I understand that this is a RELEASE OF LIABILITY, which will legally prevent me or any other person from filing suit or making any other legal claim for damages in the event of any injury or death to me. I nevertheless enter into this agreement freely.
